According to the Memorandum of Understanding, "AIESEC in Nashik" commits to the following:

### Areas of Cooperation

AIESEC in Nashik agrees to the following:

- Doing exclusive campus recruitments for students of AICESR.
- Full membership in AIESEC in Nashik.
- Participation in Leadership Conferences and other forums of the organization for the membership.
- Student testimonials for NAAC
- Devising strategies for personal and professional growth of members and the Club in synergy with AICESR.
- Complete organizational support for the membership and exchange participants.
- All kinds of involvement in events by the institute.
- Regular meets to work in synergy.
- Discounts to students of AICESR for event tickets.

- Organizing an exchange fair for the students on the college campus.
- Sending a minimum 12 number of students from AICESR on an exchange for the year 2022-2023.
- All the interested students of the age 18 and above are eligible to go on an AIESEC volunteering program.
- Certificates to all the exchange participants on completing the projects.
- Letter of endorsements to all the members on completing a term of 8 months or above.
- The college should be kept in the loop from the initiation of the exchange process until the exchange is complete.
- All the required documents for exchange should be submitted by the exchange participant to AICESR and AIESEC both.
- All the communication between AICESR and AIESEC will be through Vice President Marketing and Prof. Priya Kapadne.

## Ashoka Education Foundation agrees to the following:

ALESECHATIA

- Building student clubs at all its Higher Education Units/colleges for AIESEC in Nashik.
- Recruitment of 3 full members from each campus for commencement.
- Temporary office at the campus for meetings and other official purposes.
- Creating awareness about exchange programs run by AIESEC.
- Leave is granted to the students when they go for an exchange.
- After considering the Schedule of all Higher Education Units/Colleges provides Space to conduct various activities within the campus.
- Providing students with credit points after six months of internship at AIESEC.
- Minimum one staff coordinator to guide and support in AIESEC activities in the institute.
- Implementation of professional strategies.
- Sending a minimum 12 number of students from AICESR on an exchange for the year 2022-2023.
- Members attend training sessions (Ideally on a Sunday) initially until the Student's unit is fully established.
- The college should be kept in the loop from the initiation of the exchange process until the exchange is complete.
- All the required documents for exchange should be submitted by the exchange participant to AICESR and AIESEC both.
- All the communication between AICESR and AIESEC will be through Vice President Outgoing Global Volunteer and Prof. Priya Kapadne.



## 1. Duration and Termination

The collaboration shall be counted approved & authorized only upon the signature by the authorized officials from both parties. It will be effective from 7th February 2022 till 31st January 2023 (as decided by mutual consent).

## 2. Modifications

No modifications or alteration of any deliverables or terms and conditions of this MOU shall be effective unless made with the prior written agreement of the parties involved.

The parties involved have agreed upon these terms and are hereby incorporated in a definitive agreement proposed to be executed between the Parties. The two parties shall mutually come up with a working plan within 3 working days from the date of signature of this MoU and appoint single points of contact respectively.
