- 4. Invite the school to take part in the placement program organized by the college.
- 5. Principal and Vice Principal will be invited for Principal Talk under Employability Enhancement Cell.
- 6. Experienced teacher will be invited as a judge for different event or Resource person for guest lecture.
- 7. Faculty of AICESR will be provide inputs on Action Research.

Ashoka Universal School, Chandshi will:

- 1. Include AICESR students in training programs organized in Ashoka Universal School, Chandshi.
- 2. Allow the AICESR students to conduct internship & practice teaching in its school as and when possible.
- 3. Place the AICESR students in its school provided they are found suitable as per their requirements.

The aim of the Memorandum of Understanding shall be to achieve a broad balance in the respective contributions and benefits of the collaboration and this shall be subject to periodic review by both Colleges.

This agreement will take effect from the date of its signing and shall be valid for unlimited period from that date unless sooner terminated, revoked OR modified by mutual written agreement between Parties.

Either party may terminate the Agreement at any time by the provision of three months written notice to the other party. - Lucation
