This Memorandum of Understanding is executed on this 20th day of January, 2022 between the Party no.1 and 2 on following terms and conditions of understanding :

Whereas the Party no.1 is an Educational Institution conducting the graduate and post graduate courses in the stream of Social Work and the courses run by it recognized by the Government as well as by the SNDT University Mumbai,

Whereas, the Party no.2 is a spiritual organization working on voluntary contributions in the field of awakening of the spiritual energy within every human being irrespective of its caste, creed, religion and race.

Whereas, the Party no. 1 is interested to conduct the course of selfrealization and self-evolution through awakening of the spiritual energy within with the help of meditation for the benefit of its students and academicians and whereas the Party no.2has been a reputed and renowned Institution working in the said field as desired by the Party no.1.

Whereas, the Party no. 2 has been conducting such courses on regular basis in the academic Institutions throughout the Union Territory of India and Abroad,

Now it is therefore, requested by the Party no. 1 to conduct such course in their Institution and the same has been consented to by the Party no.2 and the present memorandum of understanding is therefore, executed by the parties on following terms and conditions.

- That, the Party no.2 shall conduct the course of self-realization and selfevolution through awakening of the spiritual energy within with the help of meditation for the benefit of its students and academicians of the party no.1 during the period starting from January 2022 onwards.
- 2) That, for the aforesaid purpose the party no.1 shall make available its students and academicians as per the course schedule prescribed by the party no.2 for the purpose of meditative and theory sessions.
- 3) That, the party no.1 shall make all necessary arrangement within its academic premises that, the session could be conducted by the party no.2 (either through online or offline mode) with the necessary aesthetics and discipline such as the audio visual arrangement, sufficient sitting space, necessary space for arrangement and accessories.
- 4) The party no.2 since is a voluntary organization and it does not charge anything in monetary terms for conducting the course, there is no consideration involved in this Agreement so far as monetary terms are concerned.
- 5) The party no.1 shall allow its students and academicians to participate in all the activities, submitting necessary feedbacks, practicing necessary

techniques, attending necessary theory and practical sessions, studying the relevant literature as made available by the party no.2 during its allotted sessions as described in the course schedule.

- 6) The party no.2 shall be at liberty to conduct the necessary surveys, prepare report and publish the same exclusively relevant to the subject matter of the workshop specially in respect of the participation, response and feedback by the participants.
- 7) That, the party no.1 shall not make undue changes in the course schedule and the allotted time unless the party no.2 is taken into confidence and intimated in advance so as to make suitable changes.

Hence, this memorandum of understanding executed between the parties on this 20th Day of January, 2022 in presence of two witnesses and will be continued for students benefits.
