The aim of the Memorandum of Understanding shall be to achieve a broad balance in the respective contributions and benefits of the collaboration and this shall be subject to periodic review by both Colleges.

This agreement will take effect from the date of its signing and shall be valid for an 3 years from that date unless sooner terminated, revoked OR modified by mutual written agreement between Parties.

Either party may terminate the Agreement at any time by the provision of three months written notice to the other party.
